HALL OF FAME INDUCTEES

PEYTON CARNES '52



I, Brother Peyton Carnes, grew up in Fort Worth, Texas and chose to go to Oklahoma University because of their great football team and because I wanted to earn a petroleum engineering degree. As fortune would have it, I joined Kappa Sigma in 1951. While there I was pledge master for one year. I met and became friends with many of the brothers, and these friendships have lasted to this day. The fraternity provided a great learning experience which has helped shape me and my entire life's path after school. It was a good time which has left me with so many good memories of those days.

After college in 1955, Sally Mugler and I married. We had a wonderful 54 year plus life together before I lost her on Thanksgiving Day in 2009. We raised four great kids who have all contributed to the benefit of those around them. I'm proud of them.

Also in 1955, I worked several months for Gulf Oil Corporation in Laurel, Mississippi until called into the United States Air Force. I served two years as base petroleum officer at Brize Norton Base west of Oxford, England.

In 1958 I worked as a petroleum engineer for Texaco in Electra, Texas and in 1961 I went to work for Stephens Engineering in Wichita Falls, Texas as a consultant petroleum engineer. Thoroughly enjoyed being a consultant for over 46 years, retiring in 2007. In connection thereto people in our group acquired working and royalty interests in several hundred oil and gas properties. It has been rewarding but much like a roller coaster ride. The low prices are not as much fun as the high prices.

About four and one half years ago I married Jane Spears and we have had a wonderful marriage. Her Dad was a Kappa Sig at Texas Tech. I'm such a fortunate guy to have two such cherished Christian women as my wives.

I have a special place in my heart for Kappa Sig and all the friends, shaping, direction, discipline, growing up, love and kindness found here. For all these good times I am so glad to see the chapter have this new house and for you members and pledges be a part of it.



JACK BACHE '56



Brother Jack Bache was born in Oklahoma City, and attended Classen High School with 8 of his pledge brothers. He joined Kappa Sigma in 1954 and was a member of one of the best pledge classes ever assembled at the University of Oklahoma.

While a member of Kappa Sigma, he served as Grand Scribe, Grand Procurator, and was Rush Chairman for two summers. He was also a member of the Interfraternity Council for the Chapter. Jack was very active in intramurals as well. He won championships in boxing and wrestling and was named to the

All-Intramural Football Team as a senior along with Brothers Fred Pike and Bob Cochran.

Jack received his Degree in Public Relations, was on the Dean's Honor Roll two years, served on the OU Intramural Board and was reporter for the school newspaper, the Oklahoma Daily.

After graudating from OU, he moved to Dallas and worked in the PR Department for a leading oil field equipment company for three years and then joined the J C Penney Co. and moved back to Oklahoma City. He was with Penney's for 17 years serving in various positions, and served as Regional Sales Promotion Manager in the Dallas office, which was responsible for Penney stores in 8 states. Traveling proved to be too much for Jack as he missed being home and being with his family and asked to be moved to a Store Manager position. This move brought him to Pittsburg, KS in 1979.

After working as Manager of the Pittsburg store, he was approached about applying for an opening as Executive Director of the newly opened YMCA. He accepted this position in 1983 and has been there ever since. When taking over the YMCA, they had 1800 members and the YMCA grew to 10,000 members. Jack added on to the YMCA on five different occasions and raised some \$4,000,000 to do this. The Pittsburg YMCA is the largest member per population base of any YMCA in the Midwest. Running the YMCA has not been a job for Jack, but a "Labor of Love" that sees him at the YMCA seven days a week. He feels his greatest accomplishment has not been growing the Y and it's membership, but in helping young people and families to be a part of the Y, who cannot afford to join. The Pittsburg YMCA currently has almost 4,000 members who recieve some form of financial assistance and no child is turned away due to financial difficulty.

During his time in Pittsburg, Jack has coached baseball for 20 years, including the local American Legion team. He has won six State Babe Ruth Championships and took two teams to the Babe Ruth World Series.

He has served as President of the Board of Directors of the local youth baseball association, Safehouse, Big Brothers/Big Sisters, the local Rotary Club and the YMCA before becoming the Director. He has also served on the Board for the local United Way, Crestwood Country Club, Red Cross, Salvation Army, and the Chamber of Commerce.

He was also the Chairman for building a new Salvation Army facility, the Humane Society, and a new gym for the local high school.

Jack became heavily involved with Gamma-Kappa when they decided to build the new house and was in charge of raising funds for the years 1953-1959, and began serving on the House Board in 2014 and served as Vice President and currently as President.

Jack is married to Judy, who is a retired Physical Education teacher, and was also the high school volleyball coach and junior high school track coach.

Jack has two sons, four grandchildren, and two great grandchildren. He has fond memories of his days as an active, enjoys working as an alum, stays in touch with many of his pledge brothers, and feels that his experience with Kappa Sigma has been one of the most important aspects of his life.

ROBERT PERRY MOORE '61



Born on September 20, 1942 in Oklahoma City, Oklahoma, Robert Perry Moore (better known as R.P. "Bob" Moore) is Sooner born and Sooner bred. His great grandfather established the family roots in Oklahoma during the land run of 1889. Bob Moore attended school in Oklahoma City graduating from Harding High School in 1960. Bob then attended the University of Oklahoma in the fall of 1960. There, he pledged Kappa Sigma Fraternity and was initiated in 1961. He served as Assistant Scholarship Chairman and Grand Scribe for the chapter. In addition to being a leader in the chapter, he was

elected President of the University of Oklahoma Student Body. He graduated in 1964 with a Bachelor's degree in Business Administration. After college, Mr. Moore furthered his education attending Oklahoma City University School of Law and received his Juris Doctorate in 1967 and was admitted to the Oklahoma State Bar Association in 1968.



After his education he acquired, Mr. Moore served his country joining the United States Army. He was stationed in Okinawa, Japan and battled in Vietnam. Upon his return from his military duties overseas, Bob collaborated with his father and brother to begin a family business. Takara Bicycle Incorporated did business locally in Oklahoma, across the nation and distributed its business to Taiwan and Japan. With this business, Bob became one of the founding fathers for the Japan-American Bicycle Trade. However, during the Carter Administration, the business would falter, Bob moved forward to practice law in 1979 by joining the Garland and Bloodworth Law Firm. Bob Moore took more an active interest in the fraternity as an Alumni Advisor for the Gamma Kappa Chapter of Kappa Sigma. He wanted to mold the young men joining the fraternity to become quality gentlemen with a successful future in their careers. Thus, this brand of mentorship, became his moment establishing his legacy in the chapter for many years to come.

It is noted, his family lifestyle mirrored his contributions in establishing futures. In 1971, he married Bobbi Ann Ingram and kept this matrimonial bond for 45 years. Bobbi Ann was an attorney as well and worked for Oklahoma Supreme Court Justice Marian Opala for 42 years. Bob and Bobbi Ann had one child, Robert whom they adopted. He was born in 1988 and currently is an insurance adjuster.

As mentioned before, Bob Moore established a mentoring style legacy for Kappa Sigma College Students. He states, "young men can't learn to be gentlemen in the colleges and universities of today". He further emphasized, "young men can learn to work with other people through their association with [the Kappa Sigma] Fraternity". This would lead to the list of his achievement dealing with this precise goal in mind. On top of leadership during his college years, as an alumnus, he became the founding father for the Kappa Sigma Fraternities at Oklahoma City University and Central State University (later becoming the University of Central Oklahoma). Gamma Kappa Chapter remodeled their house in 1985 and revamped the rush program that year to rush the top students in high schools. Quality was the key ingredient, rather than quantity. These outreaches to better the future of men entering college and the fraternity earned Bob Moore, Kappa Sigma 1985's Man of the Year award. He served on the housing corporation board for Oklahoma University and Oklahoma City University.

The awards for these achievement poured in on top of becoming Man of the Year in 1985. Oklahoma City University's Theta Psi shared the same gratitude. Because, he served as alumni advisor for that chapter as well, Bob lead the chapter to becoming the top chapter nationwide according to National Headquarters. Bob received the Michael J. Tavlin Alumni Award on November 7, 1992. Additionally, in 2004, Bob was honored with the Friends and Brothers Hall of Fame award for Theta Psi.

ROBERT MOORE (CONTINUED)



For the State of Oklahoma and the City of Oklahoma City, Bob served on several committees and advisory boards such as the former director for the OKC downtown Lion's Club and a board member of the Methodist Church of Oklahoma City. During his awarding of Man of the Year, it was quoted "The citations read on like a list out of 'Who's Who". One of the men he mentored, Ernest Nalagan, stated, "For nearly 30 years of my life, 'Doc' (as he calls Bob) has pushed me into the light and remained in my shadow watching over me. I'm forever grateful." Today at 74 years of age, Bob Moore carries his own law practice and still mentors young Kappa Sigma men by passing the torch and influencing the men he molded to becoming successful gentlemen. His legacy continues. Thus, these achievements and brand of mentorship are the reasons to award Robert P. Moore the honor to join his other colleagues as a part of the Gamma Kappa Chapter of Kappa Sigma HALL OF FAME AWARD.

STEVE OWENS '67



Brother Steve Owens was born in Gore, OK, and grew up in Gore and Miami, OK. Being one of eleven children in a hard working family meant Steve worked from an early age. His first memories of OU football are of smoking out back of the shoe store where he worked and listening to the games on a transistor radio.

Steve was recruited by OU to play football and entered the University in 1966. He pledged Kappa Sigma and was initiated in 1967.

While playing football for OU, Brother Owens was selected to The All Big Eight Team in 1967, 1968, 1969. He was named Big Eight Player of the Year in 1968 and 1969. He was a Consensus All American in 1968 and 1969. He was named Co-Captain of the OU team by his teammates in 1969. Brother Owens culminated his career in college football by winning the 1969 Walter Camp Award and 1969 Heisman Trophy, awarded to the nation's outstanding college football player and considered to be college football's most prestigious award.

Steve was drafted by the Detroit Lions in the first round (#9) in the NFL draft. In 1971, Steve became the first Detroit Lion ever to gain 1000 yards in a season. He was named to the Pro Bowl in 1971. His professional football career was cut short by a severe knee injury in 1976.

His playing days were over, but Steve's awards and involvement in OU football were far from an end.



In 1991, Steve was elected to the National College Football Hall of Fame, the Oklahoma Sports Hall of Fame, and was named the Walter Camp Foundation Alumnus of the Year. In 1992, Steve was inducted to the Orange Bowl Hall of Fame.

Returning to Norman after his retirement from the Detroit Lions, Steve has been as successful in business as he was on the gridiron. He is the CEO of Steve Owens & Associates and Steve Owens Insurance Group in Norman.

Steve's dedication to his sport, community, and state has not waned. He is a founding member of both the Norman Public School Foundation and the Miami, OK Public School, been a spokesman for the Ronald McDonald House, and played a key role in raising funds to begin the House in Oklahoma City. He has given his time to the Make-a-Wish Foundation, the Cystic Fibrosis Foundation, the Child Welfare Citizens Advisory Board, the Oklahoma Chapter of the National Football Foundation, and the Advisory Board of the Norman Family Y. He is on the Executive Board for the Jim Thorpe Association, and the Oklahoma Sports Hall of Fame. He also serves on the selection committees for both the Doak Walker Award and the Danny Wuerfful Award.

He is on the Board of Directors for Thunderbird Clubhouse, a charitable organization that is particularly close to the heart of Steve and his high school sweetheart and wife of almost 50 years, Barbara. Steve and Barbara lost their son, Blake, in 1997. Blake had struggled with mental illness and was helped by the Thunderbird Clubhouse at The Trails golf course in Norman. In 2014, the tournament was renamed "The Blake Owens Memorial Golf Tournament" in honor of their beloved son.

Steve has continued his strong ties to the University of Oklahoma, serving as the Athletic Director from September 1967 through March 1998. He has served as a member of the OU Centennial Committee, the OU Alumni Advisory Council, and OU Alumni and Friends of Cleveland County. He was the first Chairman of the Sooner Club Fund Drive. He served on the "O" Club Board of Directors and is a past president of the organization. He is a founding member of the OU Football Letterman's Association and also served on their Board of Directors.

Steve was named to the All Kappa Sigma Football Team and has assisted in recruiting pledges by bringing his Heisman Trophy to the Gamma-Kappa house and meeting with prospective pledges.

Steve resides in Norman with his wife, Barbara. They have two sons, beloved Blake and Mike. Mike resides in Norman with his wife, Lindsay and their two sons Austin and Madden. Daughter, Quincy, resides in Oklahoma City.



JOHN A. RIEGER '76



John A. "Andy" Rieger pledged Kappa Sigma as a freshman journalism student at OU in 1975. He was initiated in February of 1976. In the house, he worked on summer rush, was Grand Master of Ceremonies, House Manager and chapter president. As house manager, he was known as "Mom Rieger."

He later was alumni advisor for the chapter and was editor of the Interfraternity Council rush manual in 1977.

Rieger was editor of The Oklahoma Daily student newspaper in the fall of 1978. In high school and college he worked part-time

at The Norman Transcript. His senior year of college he joined the Daily Oklahoman and Oklahoma City Times where he worked on the copy desk and was moved to the police beat.

After a stint as the newspaper's City Hall reporter he was named bureau chief of the newspaper's south and east zoned editions. He left The Oklahoman and Times in 1985 to start a weekly newspaper in Noble and attend graduate school at OU.

His journalism teaching career began as an adjunct instructor at OU in 1987. He served as editorial adviser and assistant professor of journalism for five years before leaving to finish graduate school and help care for three young children.

The Transcript hired Rieger in 1995 as managing editor. He continued teaching reporting and community journalism classes at the University of Oklahoma on an adjunct basis for several years. For several years, Rieger has been involved first as an advisory council member and now a consultant to the Ethics and Excellence in Journalism Foundation.

In Norman he has served as chair of the United Way of Norman campaign, president of the Rotary Club, the Norman Business Association and the Norman Chamber of Commerce. He currently serves on the Norman Regional Health Foundation.

He retired from The Transcript in 2015 but continues to write a Sunday column and contribute occasional news stories and essays documenting Norman's history as well as a return to part-time teaching at the University of Oklahoma. He also works part-time in real estate and with his family's investments.

Andy's wife, Karen, a former Kappa Sigma Starduster, is an attorney whose practice is focused on health care. They have three children and one grandchild. He enjoys sailing and cycling and has completed more than a dozen century rides.



JOHN G. HESTER '81



John serves as Senior Vice-President of Mergers, Partnerships and Branch Relations for INSURICA Insurance Management Network. INSURICA currently ranks as the nation's 30th largest privately -held insurance brokerage and boasts 500 employees located in 26 cities across 5 states. In his role he oversees all components of INSURICA's acquisition program and provides executive oversight for 10 branch offices in Oklahoma and California.

He began his insurance career in 1984 with the purchase of one-half of a small agency in Lawton, Oklahoma. Since

that time he has participated as a principal or provided executive oversight of over fifty mergers, acquisitions and divestitures. He has been active in the insurance industry serving as a Member of the Board of Directors, Chairman of the Young Agent's Committee and Chairman of the Political Action Committee of the Independent Insurance Agents of Oklahoma.


